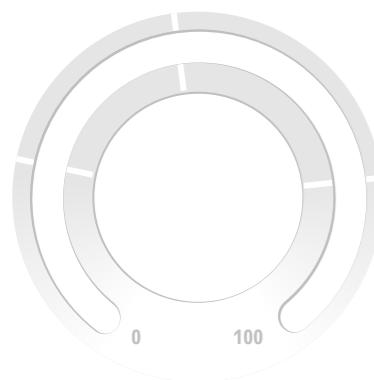

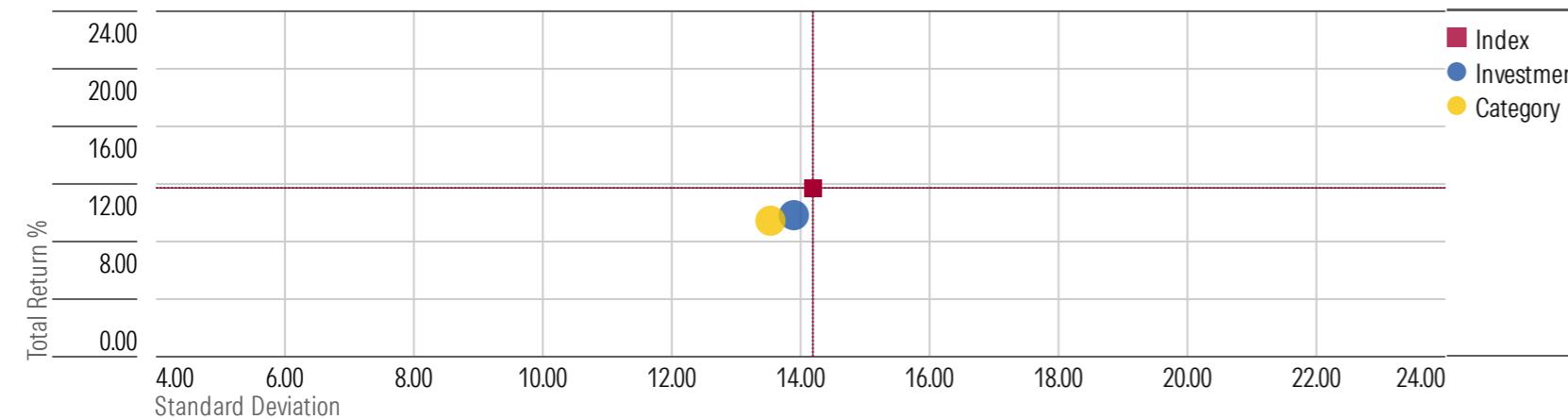
Risk vs. Category

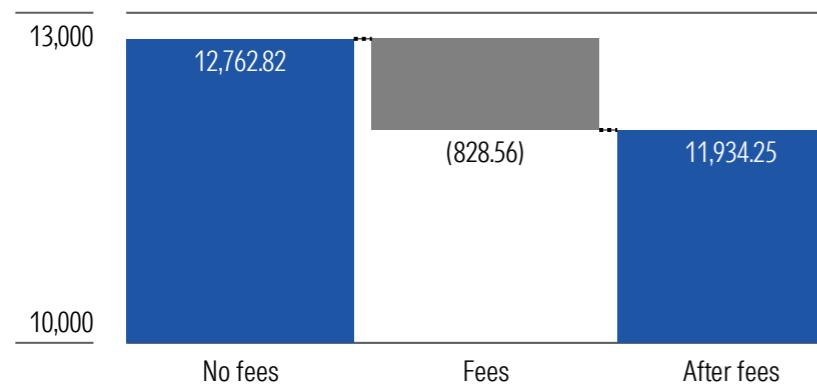

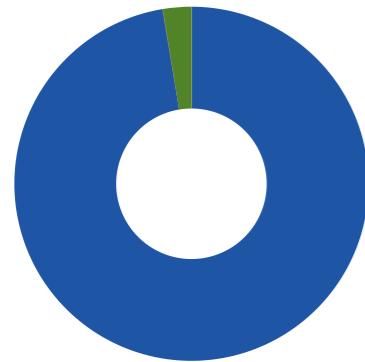

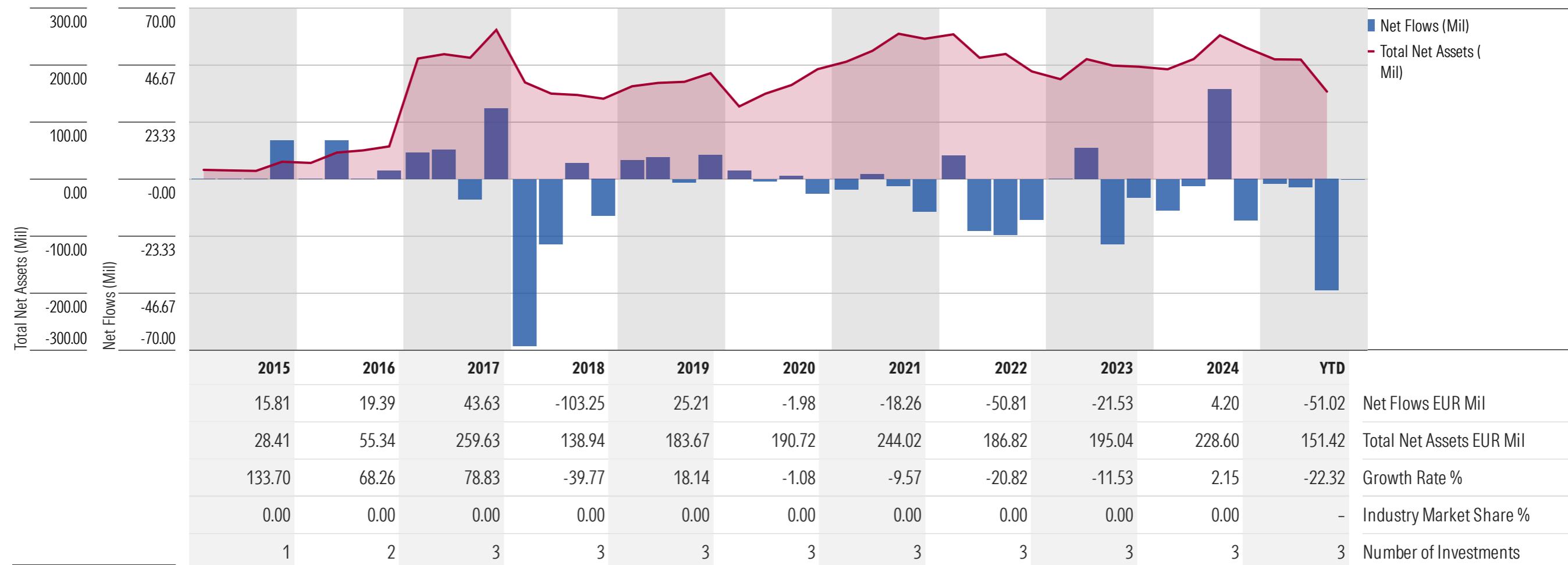
